The UN Independent Expert on SOGI, Victor Madrigal-Borloz, undertakes 1 to 3 fact-finding country visits per year.

In **2019**, he is visiting **Ukraine** and **Sri Lanka**. In **2018**, he visited **Georgia** and **Mozambique**. In **2017**, his predecessor Prof. Vitit Muntarbhorn visited **Argentina**.

In March 2018, Victor Madrigal-Borloz made **12 country visit requests**, and in this section you may find information about current status of the requests. Additionally, on 4 July 2018 **Malta** invited the Independent Expert to visit their country.
